The contract will automatically stand terminated on the completion of contract period. The renewal/extension of the contract for a period as per the Appointing Authority may concenter appropriate, shall be at the sole discretion of the Appointing Authority. Short listed candidates will be called for an Interview on a date to be intimated later.

The candidate must be a Law Graduate from a recognized university and those who have written the final law examination and their result is awaited, may also apply. However, the candidates will have to produce proof of having passed the final law examination at the time of interview.
