The qualified candidates are required to send/submit **two sets of self attested copies** of the following testimonials and original caste certificate (in case of candidates belonging to SC and ST Categories) and original disability certificate (in case of candidates belonging to Persons with Disability Category), to the Joint Registrar (Exams - DHJS & DJS), Room No. 602, Administrative Block, Delhi High Court, within 10 days, i.e. by 23.01.2020 during working hours, i.e., from 10 AM to 5 PM:

- 1 Proof of Age (Certificate of Matriculation or other equivalent examination);
- 2 Mark Sheets and Pass Certificates in respect of Xth and XIIth Class;
- 3 L.L.B. degree or other equivalent law degree;
- 4 Semesterwise Marksheets, Consolidated Marksheet, Certificates and degrees of all courses passed or attended.
- 5 Advocate's Licence if practising/Proof of enrolment/Enrolment Certificate, if enrolled with Bar.
- 6 Pass Certificate in respect of All India Bar Examination, if qualified.

In case of a candidate who claims to belong to one of the Scheduled Caste or Scheduled Tribe categories, a Certificate issued by a Sub-Divisional Officer/Additional District Magistrate/Revenue Assistant or any other Officer, who has been designated by the State Government concerned as competent to issue such a certificate.

In case of a candidate claiming reservation/relaxation on account of being Persons with Disability (Blind/Low Vision)/Hearing Impaired)/(Locomotor disability)/(Autism, intellectual disability, specific learning disability and mental illness and Multiple disabilities mentioned under clauses (a) to (d) including deaf-blindness), a Certificate issued by a Government Hospital/Medical Board in support of his/her claim.

In case of a candidate claiming relaxation in age on account of his/her being Ex-Serviceman, Emergency Commissioned Officer or Short Service Commissioned Officer, documentary evidence in this regard.
