This Court wants to replace the existing Display Board System and intends to purchase 45 nos. of 32" LCD/LED to be used as Stand-alone, 36 nos. of 40" LCD/LED to be used in Video Wall and 8 nos. 46" LCD/LED to be used in Video Wall for the use of Delhi High Court with at least following basic technical specifications:-
