**TERMS & CONDITIONS WITH REGARD TO ACCEPTANCE OF TENDERS AND
DELIVERY OF THE FOUR CARS OF DELHI HIGH COURT, WHICH WILL BE SOLD
ON "AS IS WHERE IS BASIS" AS PER DETAILS GIVEN BELOW**

- The bid will be confirmed in favour of the person quoting the highest rate in respect of that vehicle and he/she shall be required to produce proof of his/her identity and residence before acceptance of the balance payment.
- Only those bidders shall be eligible for bidding who deposit Rs. 10,000/- (Rupees Ten Thousand only) per vehicle by way of demand draft/pay order drawn in favour of "The Registrar General, Delhi High Court, New Delhi" as refundable Earnest Money with the concerned officer on or before 30/9/13 upto **11.00 a.m.** writing their name, address, telephone/mobile no., Pan Card on the reverse side of the demand draft/pay order on the spot.
- 50% of the bid amount is to be deposited by the highest bidder whose bid will be provisionally accepted, immediately on the spot by way of cash/demand draft/pay order after adjusting the Earnest Money of Rs. 10,000/- already deposited against a particular vehicle. If the amount is not deposited, the earnest money will be forfeited and the tender next below the highest shall be accepted. Similarly if the second tenderer fails to make payment of the balance amount, the next below tender shall be accepted.
- On final acceptance of the bid, the remaining 50% amount is to be deposited by the highest bidder within one week from the date of auction by way of demand draft/pay order drawn in favour of "The Registrar General, Delhi High Court, New Delhi", failing which 50% amount already deposited shall stand forfeited and vehicle will be offered to the next tenderer as at **Instruction No. 3** above. On payment of the full amount, the vehicle will be handed over to such person, which is required to be removed simultaneously.
- Vide letter F.No. M.L.O.(HQ)/Tpt/2013/626 dated 21.01.2013, the Transport Department, Govt. of NCT of Delhi has notified that the condemned vehicle is neither allowed to ply in Delhi nor its ownership can be transferred in Delhi. Accordingly, the successful tenderer will not be allowed to register/transfer the ownership of disposed/auctioned vehicles within the Jurisdiction of NCT of Delhi, in terms of the aforesaid letter dated 21.01.2013.
- The signed prescribed form of transfer of vehicle will only be delivered to the successful bidder and the original Registration Certificate of the vehicle will be surrendered to the Transport Authority concerned.
- The Registry will deal with the bidders directly and no middle men/agents/commission agents etc. should be asked by the bidders to represent their cause and they will not be entertained by the Registry.

8. Conditional bid will not be entertained. If the bid is withdrawn by the concerned party at any time after it is provisionally accepted, the entire money already deposited by him/her shall stand forfeited.
9. The Registry, in its discretion, reserves the right to reject or accept any or all the bids, partly or completely, at any time without assigning any reason therefor. The decision of the officer conducting the auction shall be final.
10. It shall be presumed that the bidder has fully inspected the vehicle before the auction. The Registry shall not be responsible and shall not entertain any complaint in respect of any defect in the vehicle.
11. The officers/staff of this Court and their family members shall not be permitted to participate in the auction.
12. The Successful bidder shall get the vehicle transferred in his/her name as per rules, at his/her own cost and responsibility, immediately on taking delivery and in any case within the time prescribed for this purpose. Delhi High Court Registry shall not in any manner be concerned with or responsible for registration of the vehicles, and will have no liability whatsoever after the delivery of vehicle to the successful tenderer.
