The authorised vendor(s) are requested to submit quotation along with the copy of current authorization letter of OEM and Demand draft/Pay order of 5% of total proposed cost for six (06) nos. of Rack Servers in favour of "The Registrar General, Delhi High Court, New Delhi-110503" payable at New Delhi towards earnest money deposit (refundable without interest on written request) in a sealed envelope to the AO(J) (IT/Stationery), Room No. 6, Ground Floor, LCB-III, Delhi High Court on or before 17/02/2020 till 5:00P.M., clearly mentioning the technical details of the product being offered. The quotation should be addressed in the name of "The Registrar General, Delhi High Court, New Delhi" and the subject of this letter & due date be superscribed on the envelope. Quotation received without subject & due date mentioned above, and without DD/Payorder towards refundable EMD, as referred above, shall be summarily rejected.

The DDs/Pay orders towards EMD of all the tenderers, except the lowest three, shall be returned on written request & EMD of successful tenderer will be returned after completing the order/after fulfilling all codal formalities against receipt. The DD/Payorder of L-2 & L-3 will be returned after awarding the work order to successful tenderer. If the offer of quotation is withdrawn by the tenderer after opening of tender or any other default, the amount of EMD will be forfeited and the firm will be blacklisted to participate in future tenders of this court.


The rates offered for six (06) nos. of Rack Servers should be inclusive of all taxes and the taxes applicable should also be clearly mentioned.

The support period (as per specification required by this tender) should also be clearly mentioned in the quotation. The validity of rates should not be less than six months from the last date of submission of quotation. Quotation with less period of validity of rates shall be rejected.

The quotation(s) received after due date shall be summarily rejected.

This Court reserves the right to modify/amend the quotation letter/terms and conditions or recall the tender notice at a later stage.
