No.F.6/33/89-Judl./Vol.I/ In exercise of the powers conferred by Section 7, 8 and 9 of the Code of Criminal Procedure 1973 (Act No.2 of 1974) as amended by the Code of Criminal Procedure (Delhi Amendment) Act 2011 and all other powers enabling him in this regard, and in continuation of Notification No.PS/DIV.COM/Misc./2011/1948 dated 11.09.2012 issued by Revenue Department, Govt. of NCT of Delhi, the Lieutenant Governor of the National Capital Territory of Delhi hereby declares and divides the National Capital Territory of Delhi into 11 Metropolitan Areas having boundaries co-terminus with the 11 Sessions Divisions (Districts) as per Annexure-I to the Notification dated 11.09.2012. The Lieutenant Governor of the National Capital Territory of Delhi is further pleased to establish a Court of Sessions for every Sessions Division.

This Notification shall come into effect from the date of its publication.
