The judicial officers shall pronounce judgments/orders in all such matters on the date fixed or maximum within a period of 2-3 weeks thereof, notwithstanding the posting/transfer. Date of pronouncement shall be notified in the cause list of the court to which the matter pertains as also of the court to which the judicial officer has been transferred and on the website.
3. The court of MM (NI Act)-02, West, THC (hitherto presided over by Mr.Mayank Goel) stands **abolished**. The Principal District & Sessions Judge, West, THC shall assign the cases pending in the court of Mr.Mayank Goel, which is being abolished, in the other existing courts so as to ensure equal pendency. The courts of Mr.Sukhjeet Singh, MM (NI Act)-03, West, THC, Dr.Ompal Shokeen, MM (NI Act)-04, West, THC and Mr.Karanbir Singh, MM (NI Act)-05, West, THC are re-numbered as MM (NI Act)-02, West, THC; MM (NI Act)-03, West, THC and MM (NI Act)-04, West, THC respectively.
4. The court of MM (NI Act)-10, South West, Dwarka (hitherto presided over by Ms.Jyoti Nain) stands **abolished**. The Principal District & Sessions Judge, South West, Dwarka



- shall assign the cases pending in the court of Ms.Jyoti Nain which is being abolished, in the other existing courts of same jurisdiction so as to ensure equal pendency.
5. The court of MM-08, Shahadara, KKD (hitherto presided over by Ms.Deepakshi Rana) stands **abolished**. The Principal District & Sessions Judge, Shahadara KKD, shall assign the cases pending in the court of Ms.Deepakshi Rana, which is being abolished to the Court of Mr.Udbhav Kumar Jain, MM-04, Shahadara, KKD.
  6. The court of Mr.Abhitesh Kumar, MM (NI Act) Digital Court-04, South, Saket; Ms.Kanika Agarwal MM (NI Act) Digital Court-05, South, Saket and Mr.Aridaman Singh Cheema, MM (NI Act) Digital Court-06, South, Saket, stand **abolished**. The Principal District & Sessions Judge, South, Saket shall assign the cases pending in the courts of Mr.Abhitesh Kumar, Ms.Kanika Agarwal and Mr.Aridaman Singh Cheema, which are being abolished, in the other existing courts of same jurisdiction, so as to ensure equal pendency.


