**NOTIFICATION**

Pursuant to the Judgment dated 15.12.2022 of the Hon'ble Supreme Court of India in Civil Appeal No. 9322 of 2022 titled *Gohar Mohammed v. Uttar Pradesh State Road Transport Corporation & Ors.*, it is hereby notified that in Motor Accident Claim Cases, if the claimant(s) or legal representative(s) of the deceased have filed separate claim petition(s) in the territorial jurisdiction of different High Courts, the first claim petition filed by the claimant(s)/legal representative(s) shall be maintained by the said Claims Tribunal and the subsequent claim petition(s) shall stand transferred to the Claims Tribunal where the first claim petition was filed and pending. The claimant(s) are not required to approach the Hon'ble Supreme Court of India seeking transfer of the other claim petition(s) filed in the territorial jurisdiction of different High Courts.

This notification shall come into force with immediate effect.
