7. The District & Sessions Judge, South, Saket shall assign sufficient number of cases to the newly created courts of Ms. Vasundhara Azad, MM (NI Act)-3, South, Saket and Ms. Niharika Kumar, MM (NI Act)-4, South, Saket on withdrawal from other such Courts so as to ensure equal pendency.
8. The District & Sessions Judge, South-West, Dwarka shall assign sufficient number of cases to the newly created court of Ms. Paridhi Gupta, MM (NI Act)-5, South-West, Dwarka on withdrawal from other such Courts so as to ensure equal pendency.
