## CIRCULAR

In view of the amendment in the Commercial Courts, Commercial Division and Commercial Appellate Division of High Courts (Amendment) Act, 2018 thereby altering the specified value from rupees one crore to rupees three lakh and Section 19 thereof, the Hon'ble the Chief Justice vide orders dated 24.01.2019 has been pleased to order issuance of the following directions:-

> "(a) The commercial suits pending in this Court with a value of rupees two crores or less filed on or after  $3^{rd}$  May, 2018, excepting those which have been specifically ordered and/or liable to be tried by this Court, may be transferred to the respective district courts.

> (b) For the purpose of transfer, these cases may be listed before the Joint Registrars (Judicial) for formal orders.

> (c) Before listing the matters before the Joint Registrars (Judicial), a notice to this effect may be published in the cause list consecutively for a period of seven days".

The above orders are circulated for information of and compliance by all concerned.
